Whereas public notice was given at least five days in advance of a special public hearing called for the purpose of discussing and approving or modifying the District's Tax Request for the 2017-2018 fiscal school year for the General Fund and Special Building Fund of Sioux County Schools District #83-0500; and

Whereas, such Special Public Hearing was held before the Board of Education for Sioux County School District #83-0500 at the time, date, and place announced in the notice published in a newspaper of general circulation; and

Whereas, the Board, provided an opportunity to receive comment, information, and evidence from persons in attendance at such Special Hearing; and

Whereas, the Board after having reviewed the District's Tax requests for the said funds, and after public consideration of the matter, has determined that the Final Tax requests as listed below are necessary in order to carry out the functions of the District as determined by the Board for the 2017-2018 fiscal school year.
